## Please sign to indicate your agreement of the following:

I understand that participating in the Brooke Elementary School "Color Me Fun Run" is a potentially hazardous activity where powdered color will be thrown at and around me during the course of the event. I understand that some of the course I, the participant, may go through colored corn starch, which has not been tested for chemicals or disease. I agree not to participate unless I am medically and physically able, which I am solely responsible to determine. I assume all risks associated with participating in the "Color Me Fun Run", including, but not limited to, slips, falls, contact with other participants, negligent acts of other participants, any defects or condition of premises, or color zones, the effects of the weather including but not limited to high heat, cold temperatures, storms, snow, ice, rain, and/or humidity. All such risks being known assumed and appreciated by me. I assume risk of wild animals and insects that may be present on the course. I agree to indemnify Brooke Home and School Association, its affiliates and assigns, from any and all third party claims caused in whole or in part by my actions. I agree that Spring-Ford School District, Brooke Elementary, Brooke Home and School Association, all board and committee members, and volunteers are not responsible for any personal items or property that are lost, stolen, stained or damaged at or during the event. I understand and agree that pets are not permitted to accompany me in the race, and children under

the age of 18 are not permitted to participate or accompany me in the race unless a parent or guardian signs a waiver on their behalf.

I grant permission to Brooke Home and School Association and its affiliates and sponsors to use any photographs, motion pictures, recordings or any other record of this event for any purpose including, but not limited to, promoting, advertising and marketing purposes. Any and all photographs, motion pictures, recordings or other records of the event are the sole property of the Brooke Home and School Association.

I understand that all entries are final with no refunds. The Brooke Home and School Association reserve the right in any event of emergency or local or national disaster to reschedule the run. Participants are expected to exhibit appropriate behavior at all times, including obeying all laws. This includes respect for all people, equipment and facilities and cooperative, positive participation. Brooke Home and School Association may dismiss, without refund, anyone whose behavior endangers safety or negatively affects a race, a person, a facility or property of any type or kind.

## All Participants - Waiver & Release of all claims and assumption of risk

I recognize and acknowledge that there are certain risks of physical injury to participants in the "Color Me Fun Run", and I voluntarily and knowingly agree to assume the full risk of any and all injuries, damages or loss, regardless of severity, that I may sustain as a result of said participation. I further agree to waive and relinquish all claims I may have (or which may accrue to me) as a result of participating in these activities against Spring-Ford School District, Brooke Elementary, Brooke Home and School Association including its staff, members, officers and employees, the race agents, volunteers, sponsors, and the operators of the venue (hereinafter collectively referred to as "Administrators"). Participants registering for the race, programs/activities must recognize that there is an inherent risk of injury when choosing to participate in recreational activities/programs. I agree that I am solely responsible for determining if I am physically fit and/or skilled for the race or activities contemplated by this Assumption and Release. It is always advisable, especially if the participant is pregnant or disabled in any way or recently suffered an illness, injury or impairment, to consult a physician before undertaking any physical activity. I, for myself and my heirs, do hereby fully release and forever discharge the Administrators from any and all claims for injuries, including death or incapacity, illnesses, damages, expenses or loss that I may suffer arising out of, connected with, or in any way associated with the race, program or activities including injuries caused or associated with transportation to and from the event. I have read and fully understand the above important information, warning of risk, assumption of risk and waiver and release of all claims.
